The Board of Directors (the "*Board*") of Harris County Municipal Utility District No. 109 (the "*District*") met in special session, open to the public, at the Atascocita Waste Water Treatment Plant, 5003 Atascocita Road, Humble, Texas 77346, and via teleconference, on April 27, 2022 at 5:30 p.m.; whereupon the roll was called of the Board, to-wit:

Owen H. Parker, President Chris Green, Vice President Cheryl Moore, Secretary Robin Sulpizio, Assistant Secretary Nancy A. Frank, Assistant Secretary

All members of the Board were present in person, with Director Frank attending via teleconference, thus constituting a quorum. Also attending all or parts of the meeting were Ms. Frayde Torres, Mr. Paul Villarreal and Ms. Holly Marback of Water Waste Water Management Services, Inc. ("WWWMS"), operator for the District.

Attending the meeting via teleconference: Ms. Jane Maher of Norton Rose Fulbright US LLP ("NRF"), attorneys for the District.

Call to Order. President Parker called the meeting to order in accordance with notice posted pursuant to law, copies of certificates of posting of which are attached hereto as *Exhibit A*, and the following business was transacted:

1. Board finding of existence of emergency or public necessity making the convening at one location of a quorum of the governmental body difficult or impossible and permitting a meeting by telephone pursuant to Section 551.125 of the Texas Open Meetings Act. Upon motion by Director Sulpizio, seconded by Director Moore, after full discussion and the question being put to the Board, the Board voted unanimously to find the existence of an emergency or public necessity making the convening at one location of a quorum of the governmental body difficult or impossible and permitting a meeting by telephone pursuant to Section 551.125 of the Texas Open Meetings Act.

2. **Public Comments**. There were no public comments.

3. **Discussion and investigation into an ePayment system for payment of water bills, and such other matters as may property come before it.** Ms. Torres discussed ePayment system for water bills. She discussed the District's rate order and the possibility of including echecks and a limit on the number of times the echecks can bounce. She stated that First Billing Services is a payment portal that the District could use. She noted that First Billing Services charges a \$1 fee for a transaction. President Parker discussed the option of the District being charged a flat fee, or if there is another platform the District could use. Mr. Villarreal stated that he could discuss options with the District's bookkeeper and with First Billing Services.

Ms. Torres stated that there 16 accounts from December that stopped payment due to the

delay with the postal service. It was the consensus of the Board to not charge a return check fee for those accounts.

Ms. Marback joined the meeting at this time, and discussed ePayment options with the Board. Discussion ensued. President Parker requested that WWWMS look into options for the District and noted that the District would like to pay potential service fees instead of passing the fees down to residents.

THERE BEING NO FURTHER BUSINESS TO COME BEFORE THE BOARD, the meeting was adjourned.
